The attention of consultants submitting responses for this RFQ is called to the following Revisions & Responses to Questions to the subject RFQ. The items set forth herein, whether of omission, addition, substitution, or clarifications are all to be included in and form a part of the qualification packages submitted.

RFQ Revisions:

Item 1:

Within Supplemental Information Package, dated July 2024, under Submission Requirements section page 3:

Delete paragraph:

"Each submission shall include a Statement of Qualifications that provides detailed information in response to the evaluation criteria set forth below and include Architect/Engineer & Related Services questionnaires SF 330 (www.gsa.gov/portal/forms/download/116486) with the appropriate number of Part IIs. M/WBE certification of the prime and sub-consultants shall be current at the time of submittal and the Consultant shall provide a copy of the M/WBE certification letter from the Supplier Diversity Office for M/WBE."

Replace with:

"Each submission shall include a Statement of Qualifications that provides detailed information in response to the evaluation criteria set forth below and include Architect/Engineer & Related Services questionnaires SF 330 (https://www.gsa.gov/system/files/SF330-21.pdf) with the appropriate number of Part IIs. M/WBE certification of the prime and sub-consultants shall be current at the time of submittal and the Consultant shall provide a copy of the M/WBE certification letter from the Supplier Diversity Office for M/WBE."

Responses to Questions:

1. Please clarify exactly what this project involves...In one place, it says and Engineer is needed for fire protection and in another place, it says an Architect for on-call design services.

MPA Response:

The consultants shall demonstrate experience in several disciplines, including but not limited to Architecture, Mechanical, Electrical, Fire Protection, Fire Alarm and Code Compliance with an emphasis on Life Safety code compliance, as it pertains to Fire Protection systems only.

2. Can you please provide details related to how architectural, mechanical, and electrical scope will be limited in 3rd party reviews? It is understood that the contract is focused on fire protection and the question is related to how that line will be drawn in scope for the supporting disciplines.

MPA Response:

The reviews will be limited to code compliance as it pertains to Fire Protection systems only.

3. Is Lean project management experience required? It is noted in a parenthetical list in Evaluation Criteria Item 3.

MPA Response:

Lean is not required for this Contract.

4. Could MAAB, ADA and accessibility be part of this Contract?

MPA Response:

No. Design/Construction Document reviews are limited to Fire Protection systems only.
